



## **Terms of Use for the Brain Architecture Game and Website**

### **TERMS OF USE**

These Terms of Use (“Terms”) apply to your access to and use of this website, [www.thebrainarchitecturegame.com](http://www.thebrainarchitecturegame.com) (“Website”), and any services or documentation linked or downloadable through this website, including, but not limited to, the Brain Architecture Game, or any template or instruction for the Brain Architecture Game (collectively, the “Services”). The Services are provided by the University of Southern California, on behalf of its Creative Media & Behavioral Health Center (“USC”), and your use of any of the Services is subject to these Terms. These Terms do not alter, in any way, the terms and conditions of any other agreement you may have with USC, or any of its schools or affiliates, for products, services or otherwise.
